National Film Board Report on Annual Expenditures for Travel, Hospitality and Conferences

As required by the Treasury Board <u>Directive on Travel, Hospitality, Conference and Event Expenditures</u>, this report provides information on the total annual expenditures for each of travel, hospitality and conferences for the National Film Board (NFB) for the fiscal year ending March 31, 2015. This report also explains any significant variance with the expenditures of the previous year, by category.

This information is updated annually and does not contain information withheld under the <u>Access to Information Act</u> or the <u>Privacy Act</u>.

Expenditures on travel, hospitality and conferences incurred by federal departments and agencies support departmental mandates and the government's priorities and, in the case of the NFB, enable it to deliver its core programs.

Raison d'être and responsibilities

The National Film Board of Canada (NFB) was created by an Act of Parliament in 1939 and is a federal agency within the Canadian Heritage portfolio. The NFB's mandate is to produce and distribute original and innovative audiovisual works that add to our understanding of the issues facing Canadians and raise awareness of Canadian values and viewpoints across the country and around the world. Over the decades, it has become the standard for audiovisual innovation in Canada and plays an important role by highlighting the changes and key events in Canadian society.

As a producer and distributor of audiovisual works, the NFB provides a unique perspective on Canada's cultural wealth and diversity. The NFB explores contemporary social issues through point-of-view documentaries, auteur animation and new-media content. Over the years, the NFB has played an important role in marking the major changes and events taking place in Canadian society. A brief description of the agency's activities for the current fiscal year can be found in the <u>2014-15 Departmental</u> <u>Performance Report</u>.





Significant variances compared with the preceding fiscal year

Travel – not related to production and marketing of films

In 2014-2015, travel expenditures decreased significantly due to the implementation of the Deficit Reduction Action Plan (DRAP). Travel for work-meetings was reduced and use of teleconferencing tools was privileged. In 2013-2014 travel expenses were incurred in connection with the development of the NFB's 2013-2018 Strategic Plan.

Travel – related to production and marketing of films

Overall, travel expenditures remained stable.

Hospitality

For the past several years, as prescribed by the applicable Treasury Board directives on travel, hospitality, conference and event expenditures, the NFB has been keeping hospitality expenditures to the minimum required.

Conference expenditures have been reduced to a minimum.
